We ensure that all practitioners employed by Lifelink are members of BACP/BABCP (or equivalent), accredited by BACP/BABCP (or equivalent) or have a timetabled schedule to work towards accreditation. Counselling staff receive monthly line management supervision and **separate** (1.5 hours per month) clinical supervision in line with BACP guidelines to maintain quality standards. Lifelink have a dedicated in-house Clinical Quality Lead, a Clinical Supervisor and a number of associate (self-employed) clinical supervisors, and we are now looking to expand this team.

This role is responsible for providing clinical supervision to Lifelink Counsellors, ensuring safe and ethical practice and support clinical performance and development of the counsellors practice.
